CCC has been established in China in 2001. Products listed under the CCC-product catalogue, which currently covers 20 product categories and 158 products according to the newest product catalogue, require a CCC-mark. The most recent revision of CCC started in 2013 and is still ongoing.

After the seminar, lunch will be offered and participants will have the opportunity for individual talks with our experts Mrs Wang Xu and Mr Haimo Huhle.

She was an expert member of the CCC Technical committee (TC) for technical certification (TC01) and factory inspection (TC02). Since 2013, she is an expert member of the CCC Technical committee for household appliances (TC04) and low-voltage appliance (TC06).
